I'd also like to share some other exciting news with you about the Fostering Futures Program! I'm sure you've all heard the name "Fostering Futures" floating around over the past few months, but not all of you may be familiar with what it is.

"Fostering Futures is a specialized training curriculum to help CASAs become better advocates for older youth in foster care (ages 14-21). These older youth face many challenges as they prepare for adulthood, including homelessness and increased pregnancy. Fostering Futures empowers volunteers with tools to plan much earlier in assisting older foster youth in their transition into adulthood."

In other words, Fostering Futures is the future of advocacy for our youth. We want to make sure that our youth are prepared to move outside of the system, and we'll do this by helping specially trained CASAs to become not only advocates, but mentors.

Fostering Futures will be part of the current CASA Training in October, but all of you are invited (and encouraged!) to attend the training as well. The training will occur on Saturday, November 2nd, from 8:30am-4:30pm at the Kapolei Judiciary. We hope that you'll join us for this very important training!

Court Practices - Tips & Tools

Here are some tips & tools from the August 17th workshop, from presenters Lauri Tochiki, Mei Nakamoto and Ray Zeason.

Tools for Avoiding a Trial

Negotiation: Negotiations can happen inside and outside of the courtroom. See if you can help all the parties come up with a solution that works for everyone!

• Ohana Conferencing: This is a great way to get the family's support system together to help make important decisions.

Mediation: An objective, third party mediator, will sit down with the parties to the case and try to help everyone come to an agreement.

Preparing for Trial

• Get the CASA file ready by tabbing all of the exhibits and documents so that everything will be easy to find.

Read all of the exhibits and documents in the file, paying special attention to your court reports and any exhibits submitted by the CASA Program. These will be the documents you'll be asked about the most.

♦ Go through trial prep with your attorney. They will tell you anything you need to know about the people you will interact with on the stand and you'll have the opportunity to practice testifying, which will help you become more comfortable.

Testifying in Court

Stay calm!

Take your time answering the attorney's questions and paraphrase their question back to them as you understood it if you need clarification on what they're asking. Don't let the attorney's rush you. This is when mistakes are made!

Be truthful, answer questions to the best of your ability, and if you don't know the answer, it's okay to say you don't know or you don't remember. Don't try to make something up!

Helpful Hints & Practical Pointers

Advocacy for Non-Verbal Children

Protecting non-verbal children is one of the most difficult and important things that we do as CASAs. These are the children who can't tell us what they're going through, and rely on us to know them, and the signs, well enough to protect them when they can't protect themselves. Below are some signs of abuse in the infancy and pre-school stages.

Infancy

Physical Abuse: Frequent crying, lack of social responsiveness, social avoidance

Physical Neglect: Lethargy, delayed growth, cognitive delays, social delays

Emotional Abuse: Anxiety-fear response, social withdrawal, mistrust of people

Emotional Neglect: Lack of social responsiveness, poor eye contact, cognitive delays, social delays

Sexual Abuse: Excessive crying, agitation, somatic symptoms, failure to thrive

Preschool Period

Physical Abuse: Aggressive behaviors, destroys property, irritable, moody, oppositional behaviors, hyperactivity

Physical Neglect: Developmental delays, lethargy, inappropriate eating

Emotional Abuse: Poor risk takers, poor peer relationships, anger, moodiness, causes trouble, need for control, oppositional, inappropriate attention-getting behavior

Emotional Neglect: Social withdrawal, high need for attention, overly dependent, separation panic

Sexual Abuse: Pseudo-maturity, provocative, explicit sexual behaviors, excessive masturbation, excessive clinging, regressive behaviors, fear
